Most recent Federal and State Tax Returns
Most recent Social Security benefit statement
Signed copies of your current estate planning documents - will, power of attorney, livin
trust, health care directive, etc.
Auto, homeowners, and other liability insurance Declaration Pages
Life insurance, disability, long-term care policies and any recent statements
Annuity contracts and most recent statement
List of income sources and income since last year. Include copies of W2s, final
paystubs from year end and most recent paystubs.
Estimation of expenses representative of the past 12 months
Most recent investment statements (banks, stocks, bonds, mutual funds, IRA,
401k, 403b, etc.)
Cost Basis information for investment holdings
Description of beneficiary designations on life insurance and/or investment accounts
Investment options and performance for employer sponsored plans
Mortgage/Loan documents, credit card statements and amortization schedules
Employee benefit books
If self-employed, copy of business succession plan and Articles of Incorporation
Current real estate tax bill
